## Stock Donations to MPH Trust

**I**t is now possible to donate securities to the Maynard-Pearson House Trust. An account has been established with Edward Jones Co. that will allow donors to gift stocks, bonds, etc. to the trust. Giving stock to a charitable organization is an excellent way to expand the amount you can afford to donate. You get a tax deduction for the gift, and the organization puts it to good—and often untaxed—use.

There are some significant potential tax advantages for making a gift of stock to a favorite charity. Generally, a donor can:

- Receive an immediate tax deduction for the value of the donated stock at the time you donate it.
- Avoid paying huge capital gains taxes on stock that has appreciated significantly in value since you purchased it.
- Reduce your taxable estate by donating stock to a charity. If you have a sizable estate, that can divert the money in that stock away from the IRS and into the coffers of your charity.

Please remember, the rules governing these donations and applicable tax benefits can be quite complex, so you should consult with your accountant or financial adviser about your personal situation before taking any action.

## President's Message

A new year has begun. 2005 was a very active year for the Apex Historical Society with some important firsts and many memorable events. We had our first ever Garden Tour this past spring. Based on the turnout and visitors comments, it was a great success. The Society's membership came out in force to let our commissioners know their feelings on preserving the Seagroves Farm. Hopefully, we have helped save a part of Apex history through those efforts. We hosted a meeting of the Wake County Historical Society at the Maynard-Pearson House and shared some of our town's history with them. Our old-fashioned plant sale was an excellent fund raiser and demonstrated how much a small group of dedicated volunteers can accomplish for an organization. It was my pleasure to present **Harry Beasley** with the Preservationist of the Year award. It was with sadness that we marked the passing of **Rachel Lewter**, one of our oldest members.

It has been my privilege to serve as your president through 2005, and I want to take this opportunity to thank you all for your help and support. I particularly want to thank that group of volunteers who always support the Society and give so much of their time to the Maynard-Pearson House.

Going forward, my biggest concern for the Apex Historical Society is lack of membership growth. The population of Apex has roughly tripled since the society was founded. However, our membership has not significantly increased.

Can it be that none of these new people have an interest in the history of Apex or in preserving that history? I don't think so. "Small town atmosphere" and the "history" are the reasons many of these new residents cite when asked why they chose to live in Apex. Is it that they don't know that a historical society exists? I don't know. We participate to some level at most town events. Clearly, we don't have one of the big booths on Salem Street for the Peak Festival and other events, but we are there. Many people bring their children (big kids too!) past our booth to visit the caboose. Somehow our

message is not compelling many of these people to join us. Perhaps people know we're there but don't have any idea what we do or how they could fit in our group? I know at this year's Fourth of July festival one lady asked me very specifically, what exactly does the historical society do?

Finding answers to these questions will impact the future of the Apex historical Society as a viable organization. We need people to come forward with ideas and a willingness to help in turning this situation around.
